Call to Artists

Entry Deadline February 18, 2012

Eligibility:

Only RECENT ORIGINAL 2D works including, but not limited to; printmaking, painting and drawing. Work must have been completed within the past two years.

Awards:

Cash Awards will be given for 1st place - \$1,000; 2nd place - \$500; and 3rd place \$250. Selections made at the juror's discretion.

Entry submission format:

JPEG images must be clear, professionally presented, and accurately represent the work. If work arrives that is different than the submission the organizers reserve the right to refuse it.

Please use the JPEG format where the largest dimension (length or width) should not exceed 1000 pixels and please set the image resolution at 72 dpi.

Each image should be named as follows: artist's last name_first name_entry number. For example; smith_mary_01.jpg, smith_mary_02.jpg, etc. Please list all included works on or in the CD case with number as on the hard copy entry form, artist's name, and title of work, media and dimensions. Hard copies to be included: 8.5"x11" printouts of each of the works submitted. Please do not send fancy binders or bulky cases. CDs will not be returned.

Entry Fee:

A fee of \$30 (non-refundable) must accompany application form. The entry fee entitles one artist to submit up to 3 works for consideration.

Accepted Work:

All artwork must be for sale. Accepted work must be wired and ready to hang. After work has been accepted, a substitution cannot be made, nor a change in the sales price or title as stated on the application. Artwork must remain in the gallery for the entire exhibition. No early withdrawals.

Juror Background:

Julia Kristmundsdottir was born in Reykjavik, Iceland, and currently lives in Tampa, Florida where she is an instructor of Painting and Drawing at the University of Tampa. She received her MFA in painting at the University of New Orleans in 1998.

Her work has been exhibited in numerous exhibitions and shows in the US including The Arthur Roger Gallery in New Orleans, the New Orleans Contemporary Art Center, The Art Center in St. Petersburg, and a range of other different and varied settings. She has also participated in various shows in Reykjavik, Iceland, and a public display in Pretoria, South Africa.

Her work has been reviewed in various publications and she remains involved in promoting and working with various art associations.
